### Children in their Pre-school Year

On 16<sup>th</sup> April you will receive your offer of a school place. We don't get any notification of this, so do let us know where your child is going to school. Visits will continue to schools this term, and we will liaise with local schools to arrange for teachers to come and visit the children at Esklets so they can observe them learning in their nursery setting.

## Government Funding Explainer

Please remember that due to a county funding anomaly we have an unfunded week this term. Parents in receipt of funding have been asked to let us know if they wish to take a week's holiday or pay for a week. If you have not already told us of a holiday week we will assume you are going to pay for a week and will adjust your bill accordingly. This charge will be added to your May invoice.

15 hours funded childcare for 3- & 4-year-olds – this is a 'universal' funding. All children are eligible and you don't need to do anything!

30 hours funded childcare for 3- & 4-year-olds — If your child turns 3 between 1st April and 3ist August and you are eligible, you will need to apply for your 30 hour funding ready for September. If the code isn't in place before the 31st August, the funding will not be valid. New Funding for working families — from September children over 9 months may be eligible for 15 funded hours. If you are eligible, you will need to apply this term, ready for September. If the code isn't in place before the 31st August, the funding will not be valid.

Funding for 2 year olds in 'disadvantaged' families — this is an existing funding available for families on certain benefits. If you are eligible you will receive a code from North Yorkshire Council, entitling your 2 year old to 15 funded hours.

#### <u>Fees</u>

As you already know, we have made the difficult decision to increase our fees for this financial year. Below are the new rates.

Hourly rate for all unfunded children / hours in excess of funded entitlement - £6.25 (rising to £6.50 in September).

Contribution towards consumables for funded children - 50p per half-day session (no increase)

#### Tax-Free Childcare

Do you know about the Government's Tax-Free Childcare Scheme? It is a scheme to help families with childcare costs. If you go onto the childcare choices website, you can find out if you are eligible. A lot of families don't realise they are eligible — for every £8 you pay towards your childcare costs, the government will top it up to £10. You can claim this from when your child is born up to when they are 11.

### Committee

As you know, Esklets is a charity run preschool. This means that we must have an active parent committee in order to operate. This is just an early warning that at the AGM — held in June — we will need to recruit some new committee members. It isn't an onerous task — we have one committee meeting / term, usually at the pub — and the committee usually aim to do one fundraiser each term. Do speak to staff if you would like more information.

## Sunny weather

Hopefully the weather is starting to improve, but do ensure that your child has a warm layer and a waterproof coat every day. When they are needed, we have plenty of sunhats available at Esklets, so don't worry if you forget to bring one. Please apply suncream before you come to Esklets — we will assume children have suncream on when they arrive and will not apply it as a matter of course in the mornings. If your child attends for full days we will apply suncream after lunch, unless you tell us that they are wearing a long lasting cream. We have children's suncream available, but do bring your own in if you prefer children to use a specific brand. Please complete and return the permission slip at the bottom of this page.
