It has been a different for us as we successfully trialled opening outside of termtime – we are now looking forward to everyone being back. I have a very similar child-led, in -the -moment learning ethos to how Esklets already operates. New Opening Hours -

We are aiming to offer year-round childcare at Esklets, opening 50 weeks / year from 8.30 – 4.00. We need this to be financially viable so are initially trialling it for this school year. What to send with your child –

Please could all children bring a bag with a spare pair of clothes in. We do have clothes that children can get changed into, but sometimes these don't come back to the setting (socks especially!) Other things that we would suggest putting in their bag are: a sun hat, their own sun cream if you use a specific brand (we do have sun cream in the setting), a pair of shoes if you send your child in wellies.

Packed Lunches –

A polite reminder that Esklets promotes healthy eating, so please do not send your child with chocolate, sweets or crisps. We offer children milk and water all through the day, so you do not need to send them a drink, and all children are offered a midmorning fruit snack. If you need any advice on healthy eating, you can either speak to Vicky or Rachel or look at our website.

• Car park – Could we remind everyone arriving at Esklets in a vehicle to adhere to the 5mph speed limit past Station House and into our car park. <u>New Opening Hours – trial period</u>

Open 8.30 – 4.00 Monday, Tuesday, Thursday and Friday, except for Bank Holidays and from 19^{th} December to 2^{nd} January.

Please see the attached calendar – school term time dates are highlighted green, extra weeks open during school holidays are highlighted <mark>blue</mark>, weeks closed are highlighted grey. Wednesdays are <mark>purple</mark> as we are currently closed on this day. Please read the following statements carefully and tick the one that **currently** applies to you and your child.
